Program Overview

- Pre-Pathway Program (P3) and Beyond is launching for Home Health & Hospice Employees
- Grant-funded Opportunity through Agency of Human Services
- Offered in partnership with CCV, this Program offers the opportunity for employees to begin their education in healthcare through general education coursework. Classes will also provide a chance for employees to explore which specific healthcare careers may be of interest to them.
- Program is intended to provide a foundation to enable employees to prepare for future Pathway programs within the UVM Health Network or other healthcare related coursework.
 - Participation in P3 does not automatically guarantee entry into other Pathway programs
- CCV Coursework for Spring Semester 2025
 - Vouchers available for courses related to healthcare career advancement

Work Hours

- Employees retain full-time working hours.
- Classes are in addition to work hours and are unpaid.
- It will be your responsibility to complete all work shifts as scheduled as well as attend classes and complete coursework.

Funding

Grant-Funded

P3 and Beyond is a one-time grant-funded opportunity. Funds expire 6/30/25.

Eligible courses (that will enable a participant to advance their healthcare career) will be paid in full by grant-funds.

Tuition, fees, and textbooks will be paid in full by grant funds.

Additional financial aid may be available using federal or state aid.

Eligibility



Successful candidates for this program must:



Be employed by and be in good standing UVMHN Home Health & Hospice with "favorable performance"



Currently work at least 72 scheduled hours per pay period*

*part-time employees may be eligible if funding allows for additional participants; per diem employees are not eligible



Meet all requirements of and be accepted by both HHH and CCV to participate in the Pre-Pathway Program

How do I apply?

Please submit a **completed** application via the UVMHN website

Application must include:

Letter of Interest (inclusive of career and future Pathway program goals, if known)

Director Supervisor Letter of Recommendation

(with written confirmation of departmental ability to support employee and their schedule during completion of program)

Deadline for UVMHN application: January 6th, 2025



Consider Time & Place for Coursework

- Adjust schedule for in-person or Zoom meeting times
- Plan on 9-12 hours of homework each week for a 3cr course
- Make uninterrupted time/space
